FORMAT: The NTPGA Senior Players Tour – Championship Series at Denton C.C. will be contested at stroke play over 36 holes, 18 holes each day.
DIVISIONS: (1) Overall Field
ENTRY FEE: \$425.00 non-PGA Professional; \$375.00 PGA Professionals & Apprentices; and \$325 Amateurs.
ENTRY DEADLINE: Entry forms shall be returned to the Northern Texas PGA via mail, facsimile, online, overnight carrier or in person, prior to Thursday, October 20, 5:00 p.m. CDT.
STARTING TIMES: Rounds one and two will commence with Tee Times starting between 8:00 a.m. & 8:30 a.m., based upon size of field.
PRACTICE ROUNDS: Please contact the golf shop for practice round fees and times.
DRESS CODE: All contestants will be allowed to wear golf shorts (Bermuda length) during the championship and practice round.
GROOVE POLICY: The NTPGA Senior Players Tour WILL NOT adopt the USGA Rules of Golf policy on grooves for 2011.
