CHAPTER / PRO-AM EVENT HOST PROFESSIONAL RESPONSIBILITIES

- All Chapter Championships and Pro-Ams must be conducted at a course with a PGA Member or Apprentice Head Professional, unless otherwise approved by the Executive Director
- All Pro-Ams must be scheduled through the Chapter Tournament Committee Chairman
- Host facility must acknowledge each entry as accepted, alternate, and/or field is full
- Check professional eligibility with the Section office of professional participants three (3) days prior to the event
- Verify amateur handicaps
- Host facility must have starting times available three (3) days prior to the event
- Reserve host course for participants only during competition
- Define and mark golf course properly
- Prepare a Local Rules sheet and Official Score Cards with correct handicaps denoted
- Provide registration and scoring areas for the competition
- Provide an effective weather warning system to be used in the event of dangerous weather
- Prepare and distribute gift certificates to amateurs immediately following play
- The prize fund shall be distributed to a minimum of 33% of the starting field
- Send out the professional prize distribution to the individual professionals within five (5) days following the event
- Send a tournament summary outlining the final results, number of participants and enclose a check for the Chapter Sanction Fee to the Section office within five (5) days following the event
- Sanction Fees are currently \$5.00 per contestant in the event for the Metro Chapter
- Sanction Fees are currently \$10.00 per contestant in the event for the East Texas and West Texas Chapters

TOURNAMENT RULES & REGULATIONS SUMMARY RELATED TO CHAPTER / PRO-AM EVENTS

- The host professional must send the Section office a Chapter Pro-Am/Professional-Only event summary outlining the final results, number of participants and enclose a check for the Chapter Sanction Fee within five (5) days following the event. *Failure to send a Chapter Pro-Am/Professional-Only event summary/sanction fee: Minimum \$50.00 fine.* (Article V, Section 2w and Section 2x)
- For professionals bringing fewer than the number of amateurs to a Pro-Am competition than previously committed. *Penalty: Minimum \$50.00 fine.* (Article V, Section 2r)
- Failing to appear for any round of a NTPGA sanctioned event for which a player enters and is accepted. Note: If a competitor decides to withdraw from tournament play, the competitor must notify the host professional. (Article V, Section 2s) Penalties as follows:
 - A professional enters a Pro-Am competition; accepts and fails to appear. *Penalty: Minimum suspension of playing privileges for six months and minimum \$100.00 fine.*
 - A professional cancels from a Pro-Am competition on the day of the event or the previous day; he fails to find an eligible professional to take his place (if no alternates are available). *Penalty: Minimum \$100.00 fine.*
 - An amateur enters a Pro-Am competition; he is accepted and fails to appear for any round. *Penalty: Forfeiture of privilege to enter future NTPGA/Chapter events for a minimum of 60 days.*
- Verifying an incorrect handicap for an amateur. *Penalty: Minimum \$100.00 fine and minimum six months playing suspension.* (Article V, Section 2u)

ELIGIBILITY REQUIREMENTS

- NTPGA Members and Apprentices who are in good standing on the date of the chapter tournament or Pro-Am.
- A PGA Member of a Section other than the Northern Texas Section may be invited by the host professional to participate in a Pro-Am; however not more than three (3) may compete. A Member of another Section does not have to purchase a Chapter Player's Card*.
- NTPGA Members that hold one of the following classifications may be invited by the host professional to participate in a Pro-Am; however they must purchase a Chapter Player's Card* upon approval by the Chapter Tournament Chairman. No more than three (3) Members with one of these classifications may participate in a Pro-Am.
 - Inactive
 - Ineligibly Employed
 - Unemployed
- NTPGA Apprentices that are suspended or Class "F" Members are not eligible to participate in a Chapter tournament or Pro-Am and do not have the option of purchasing a Chapter Player's Card*.
- Non-PGA professionals may be invited by the host professional to participate in a Pro-Am; however not more than three (3) may compete and a Chapter Player's Card* must be purchased for each professional. This must be done upon approval by the Chapter Tournament Chairman.

**Chapter Player's Cards are only available for Pro-Am events and may not be purchased for a professional only event.*

**Chapter Player's Cards are available to purchase for \$25.00 and are payable to the Chapter in which the Pro-Am is being conducted. Chapter Player's Cards must be purchased prior to a Pro-Am. A maximum of three (3) Chapter Player's Cards may be used per professional in a calendar year. It is the responsibility of the Chapter Tournament Chairman to manage this responsibility. All funds generated stay within the Chapter. (Article VI, Section 2g)*
