- Format:** Individual match play contested over 18-holes. There is no consolation bracket.

- Entry Deadline:** **Wednesday, October 13 at 5:00 p.m. CDT.** Entry forms shall be returned to the Northern Texas PGA via mail, facsimile, overnight carrier or in person prior to the entry deadline. **On-line entries will be accepted at [www.ntpga.com](http://www.ntpga.com).** Applications late or incomplete will not be accepted. Contestants who do not return an entry by the stated deadline will have their spot in the field replaced by an alternate from the player of the year standings.
- Contestants who have entered may withdraw and receive a full refund, minus the \$10.00 administration fee, prior to 5:00 p.m. CDT on Saturday, October 16<sup>th</sup>.* To withdraw, call and/or leave a message for Harold Geyer at (972) 765-7037. After this time, the seedings and first round matches will be finalized. If a contestant withdraws after 5:00 p.m. on Saturday (or no shows) they will not receive a refund or payment for loss of first round match. They will **not** be replaced in the field by an alternate; therefore their opponent will receive a bye in the first round.
- Starting Times:** First round seedings and starting times will be available by calling Shady Oaks Country Club or checking [www.ntpga.com](http://www.ntpga.com) after 9:00 a.m. on Sunday, October 17<sup>th</sup>. See enclosed match play bracket for approximate starting times.
- Practice Rounds:** Practice rounds will be available weekdays beginning September 21<sup>st</sup>. A limited number of practice rounds will be available on Sunday, October 17<sup>th</sup>. Please contact Shady Oaks Country Club to schedule a practice round. Please note that the facility is closed on Mondays.
