- Format:** The competition will be conducted over 27-holes. A different format will be used for each respective nine holes. The formats will include scramble, Four-Ball stroke play and modified Foursome stroke play (both partners will tee off, choose the best tee shot and play alternate shot until the ball is holed).
- Purse:** \$7,500.00 estimated total purse (based on a field of 54 teams).
- Entry Fee:** **\$160.00 per team.** This includes cart/range fees and lunch after play.
- Entry Deadline:** **Thursday, February 18 at 5:00 p.m. CST.** The first 54 team entries will be accepted into the field. Entry forms shall be returned to the Northern Texas PGA via mail, facsimile, overnight carrier or in person prior to the entry deadline. Online entries will be accepted at [www.ntpga.com](http://www.ntpga.com). *Note: When registering online, one credit card will be processed for the entire team entry fee.* Late entries will be accepted on a space available basis with a \$25.00 late fee.
- Starting Time:** **Play will commence with a 9:00 a.m. shotgun start.** Groupings will be available by calling Prairie Lakes Golf Course, the Northern Texas PGA or by checking [www.ntpga.com](http://www.ntpga.com) after 3:00 p.m. on Friday, February 19.
