- Host Professional:** Nolen Howard, Head Golf Professional (903) 581-7723.
- Eligibility:** Open to eligible NTPGA Members and Apprentices who are employed in the East Texas Chapter.
- Format:** 18 holes at Four-Ball Stroke Play. Teams will be comprised of one (1) Professional and one (1) amateur partner. Amateur partners will receive 75% of their handicap.
- Separate Tees/  
Same Purse Policy:** Professionals will play from the GOLD tees. Professionals 60 years of age and older may play from the blue tees. Amateur partners will play from the blue tees. Amateurs 70 years of age and older may play from the white tees. Prizes will be awarded to 1/3 of the field. Amateurs will be paid in gift certificates redeemable in the Hollytree Country Club golf shop. Prizes will also be awarded to the Low Gross and Low Net amateurs, for closest to the hole on all par 3's, and to the winner of the putting contest.
- Entry Fee:** **\$200.00 per team.** Entry fee includes both contestants' golf car, range balls, lunch prior to the round, prize fund, and hors d'oeuvres after the round.
- Entry Deadline:** **Wednesday, September 8 at 12:00 p.m. CST.** Entry forms shall be returned to the Northern Texas PGA via mail, facsimile, overnight carrier, or in person prior to the entry deadline. NOTE: A \$10.00 administrative fee will be charged should a team withdraw.
